POINT SYSTEM

Leaving the scene of an accident resulting in property damage of more than \$50.....6 points
 Unlawful speed resulting in an accident.....6 points
 Reckless Driving or Failure to Stop at a Stop sign or Traffic Signal or Steady Red Light.....4 points
 Any moving violation resulting in an accident.....4 points
 Unlawful speed – 16mph or more over lawful or posted speed.....4 points
 Unlawful speed – 15mph or less over lawful or posted speed.....3 points
 All other moving violations.....3 points
 Improper equipment or vehicle in an unsafe condition.....2 points
